RCS NOTES ON CLIMBING SAFETY: THE INTIMIDATION FACTOR

A new RCS proverb: Speak up while you still have the chance-or- it's OK to be kind to your mother, but it's better to blast your climbing partner!

Kathy Crandall, our new Vice Chairman, has asked me to write a brief note to start a Mugelnoos series on climbing safety. In sorting through my axioms and theorems on safety I have selected from personal experience something too new in my mind to be a Law--maybe it is a proposition.

While belaying the leader at Tahquitz, I held a 30 foot fall that should really have been only a 10 foot slide. The extra rope footage was supplied when two chocks placed after a traverse at the base of the pitch came out. This occured because the belay was anchored in the wrong place - about 20 feet from the climbing route. OK, that was a mistake, but what's the point? It's this: I knew when the leader placed the first nut that we had set up the belay in the wrong place. Why didn't I speak up at that time? Because the leader was by far my climbing superior, too tough, full of nervous energy, short on patience, bitterly vocal when crossed...I knew that my ears would ring if I asked him to anchor in while I moved the belay. So I remained silent and the eventual fall was scaled up in severity. Fortunately the injuries were minor.

Later I concluded that the safety factor of a climbing team is reduced if there is not a free flow of safety suggestions between partners as the climb progresses. This interchange <u>must</u> occur regardless of the temperment of the climbers. It is important for our students in their first climbs. It is important for our senior members. Better to speak up and get insulted in return — at least the safety recommendation is out in the open where it can be rejected or accepted. Better than being surprised later.

I have also concluded that some other RCS accidents might have resulted in a similar way. I would be interested to hear from Mugelnoos readers if there really is an Intimidation Factor in climbing safety. EY

NEWS FROM WASHINGTON

Just a note at renewal time... We have not been near the Northwest's most celebrated mountain this year, but we found pieces of it everywhere we went. Trails have a sandy deposit on them, quite fine and dusty in some areas (depending on how hard the wind was blowing at the time of deposition). Glaciers are covered with a grey grit similar to the usual end-of-season grime but more extensive. The glaciers were melted back a little more than usual this year because of their dark coating.

We climbed Mt. Olympus the weekend after Labor Day for an exciting close to an otherwise undistinguished climbing season. Olympus is not a high summit although at 7965 it is the highest on the Olympic Peninsula of Washington. Its distinguishing features are the facts that 1) the shortest approach hike is over 17 miles (round trip from the road to the summit is 44 miles) and 2) the summit receives the highest amount of precipitation of any point in the Olympic Rain Forest. We were lucky and managed to get to the summit on a day which was perfectly clear. We were able to see the snowy coastal range of British Columbia, all the volcanoes of Washington and even Mt Hood in Cregon. And behind us, we could see the Pacific Ocean! An astounding range of view.

The climb itself is mostly glacier tromping, with a short steep snow pitch and a bit of rock scramble to the summit pinnacle. It's a very satisfying summit because of the bit of workat the end - a great place to savor the scenery.

We ran into John Mendenhall at a meeting of the Mountaineers. We enjoyed a little reminiscing with him about the clear skies and simple ridge systems of the Sierras, and good rock.

We're gearing up for the ski season now. We use both kinds of cross-country gear, but we saw some startlingly short radius telemark turns last year. This winter will be the year of the telemark for us.

The August Mugelmoos published some corrections to Randy Vogel's book of topographic diagrams to Tahouitz and Suicide Rocks. Randy has replied, thanking those who noted mistakes and asking for further corrections or comments. He adds, "I am in full agreement about adding Angle Iron Traverse, Fitchen's Folly, and the Offshoot, although Angle Iron is more of a variation than a route. Some climbs were not included, however, due to doubt as to their credibility—for example, Dilemma at Suicide, which local opinion holds to have never been climbed. Free Lance has been chopped and does not really exist any more."
