STONEY POINT

Last month's issue contained an article on the status of Stoney Point and the efforts being made for its purchase by the City of Los Angeles for conversion into a City Park for recreation purposes, including climbing. Councilman Hal Bernson, whose district includes Stoney Point, has sponsored a bill, calling for such purchase, which is to be voted on at the March 30 meeting of the City Council. Club members and other interested people are urged to write as many Council members as possible in support of this bill, stressing the desirability of such a park, and that no City funds are needed for the purchase, as State bond and "Quimby" funds, already on hand, are sufficient. CHAPTER APPROVES NEW SMS SAFETY POLICY

The Angeles Chapter Safety Committee approved the new SMS safety policy on March 2, 1981, and it is now in force. Copies will be sent to all leaders and to anyone else who asks for one. Send SASE to Owen Maloy, 4591 Green Tree Lane, Irvine 92715. The reason for this new policy is that the SMS has always operated under its own rules which were tonsistent with those of the Chapter, particularly with regard to leadership training. The new policy represents an agreement between the Chapter and the SMS that SMS training is reasonable so long as leaders are in fact adequately trained in First Aid, navigation and snow safety. Under this policy, all SMS ski tours, hard or easy, are rated 'T', and are led by leaders holding the SMS 'T' rating. All ski tour leaders must also hold an Angeles Chapter : I rating (or better). Exceptions can be made for out-of-town leaders. To obtain the 'T' rating, a new leader must have First Aid, navigation and ski-touring skill and experience equivalent to the Sierra Club Ski Mountaineer ing Test. This is essentially the same policy adopted by the section on January 17, 1940, when the SM Test was adopted as the criterion for Big Badge membership. Until 1954, only Big Badge members were considered qualified leaders. Since then the same standards have been observed, but less formally. The new policy merely clarifies how these standards are to be applied and made consistent with the Chapter's standards for First Aid and (Continued on page three.)

BIG ROCK, MAR 28

This is a large granite face offering many fine routes, mainly friction, of various degrees of difficulty. It is near the eastern end of mile-long Perris Dam, which contains the waters of Lake Perris, a few mile: SE of Riverside. Take Rte 395 south out of Riverside for a few miles. Turn east on the Ramona Expressway. 2-3 miles and 2-3 traffic lights later, turn left on the road (well marked) to Lake Perris State Park. At the toll gate (it used to be 1.50 per car) ask for directions to the Big Rock parking area. The road runs along the foot of the dam - about a mile. A trail leads around the dam, over a shoulder and back down to lake level at the Rock. To get to Rte 395 at Riverside, take Rte 60 (POmona Fwy) straight thru Riverside (60 becomes 395). From Orange Co, Long Beach, San Pedro and South Bay areas, take Rte 91(Riverside Fwy) but turn off about 8 miles short of Riverside, south onto Van Buren Blvd, which intersects 395 just north of Ramona Express way. This saves 8-10 miles.

It was great to see you at Mug. last month.



SMS SAFETY POLICY (Continued from Page One)

What this means is that while a new leader will need to attend the Chapter's Leadership Training lectures, obtain First Aid and CPR cards, and pass a navigation checkout, the rest of the training is up to the Section. Mormally an overnight snow camp leader must have an 'M' rating, which requires additional Chapter training, but the SMS has always been exempted because of the Section's higher standards for snow training. This exemption is now formal and permanent.

If there is rock or snow climbing incidental to a tour, the leader must be capable of leading such a climb, and the tour will be rated T/M' (Class 3) or 'T/E' (Class 4), as appropriate. These ratings only apply when participants are expected to really need ice axe, crampons and a rope for safety, not to the usual easy

summit scramble.

There is a provision for technical climbing, jointly with RCS, under RCS rules, for those who want to do some serious winter mountaineering. When the SMS and RCS were young, many people who belonged to one section also belonged to the other, They skied in the winter and climbed in the summer, and didn't worry if things overlapped a bit.

The policy also recognizes the regular Angeles Chapter trip rating system and

corresponding leadership ratings for non-skiing trips, if any.

On any trip, there is one principal leader who must have at least one assistant with the same rating. The principal Reader has the sole authority to screen participants. The former "guest" policy, in which any qualified leader could bring any guest for whom he or she would accept responsibility, no longer applies. This practice is perfectly reasonable in the RCS, where people climb in ropes of two or three, but led to dissension in the SMS where an entire group skis together.

Leaders have complete authority to determine the equipment and skill requirements for the ski tours or other outings they lead. The policy states that Fourth Class skiing ability and the use of equipment designed for mountaineering should be required except for the easiest ski tours. It would be foolish to take someone who cannot even snowplow into the backcountry. The purpose of the Fourth Class test is "To determine the candidate's competence to engage in easy cross-country ski tours." The section runs checkout tours to assist leaders in screening participants. Checkout tours will include Third Class as well as Fourth Class testing, since Third Class skiing ability is required for leaders and possibly also for participants on more difficult trips.

There is no distinction in the rules between Nordic and Alpine equipment or technique, but it is required that leaders and participants be competent on each

"substantially different" kind of equipment they use.

The policy incorporates very slightly modernized versions of the Sierra Club Ski Tests and the Ski Mountaineering Test, eliminating archaic wording, and providing for ways of passing the tests on tour rather than in a formal test requiring a preset course. Because the Sierra Club no longer has a Winter Sports Committee, the SMS is now the sole custodian of the tests within the Sierra Club.

It should be emphasized that this new written policy simply codifies existing SMS practices and makes them consistent with Angeles Chapter policy (and vice versa). It does not change the essential purpose of the section, namely, "to enjoy skiing in mountain wilderness with the comradeship and safety of a group."

BUTTERMILK COUNTRY SKI TOURS February 14-15, 1901

Finally the Ski Mountaineers found a little snow. The idea of skiing the canyons west of Bishop didn't work out too well -- the road we tried was closed by snow several miles away from the interesting skiing. Abandoning that, we drove up Bishop Creek and found that the snow had melted so much that the rocks were showing. Finally, we simply skied to Lake Sabrina and toured the lake.

Having had enough of that, we went to Mammoth and explored the Sherwin Bowl area. e were accompanied by the youngest newly-qualified skier -- Billy Ossofsky, age 10, using his brand-new Ramer bindings. Roy Arnold also passed the Fourth Class test in typical mountaineering snow (half-frozen Sierra cement).
