eservations have Walking up the Whitney trail in Oct. 1981, Miguel and I made long plans to attempt the East Face in full winter conditions. It remained just another plan until 17 Feb. 83 when the weather held for most of the 4 days, allowing us time to complete this (at least for me) bold climb. Since the Whitney Portal road is closed at the first serious bend, we found ourselves snowshoeing well into the night just to reach Whitney Portal by 2:00 AM on Friday. Four hours of sleep had to do.with a hard day ahead! The snow at the East Pace approach route was unconsolidated and deep, testing our ability to control the snowshoes and falls. Half way up to Lower Boy Scout Lake, a furious storm hit us, forcing us to put our tent up, but also gave us two hours of much needed sleep.

wake up call at 2:00 PM saw us taking down the tent in somewhat improved weather and continuing toward Lower Boy Scout Lake. The weather prediction for a Friday storm was 100% right, and a terrible wind forced us to put our tent up at the Lower Lake. The weather finally cleared by midnight and gave us the needed time to get to the East Face Lake. The slabs above the Boy Scout Lakes are pretty steep when covered by snow, but at least we could switchback our way up without problems. (For our ice climbing friends - there is a nice one or two pitch(practice) frozen waterfall on the north side of the ridge, above Upper Boy Scout Take). The real test came in the last several hundred feet - crossing the final ridge toward the East Face Lake basin; we found the snow knee to hip deep and almost impossible. Miguel dedided to climb the ice coated 4th class rocks to the right of the chute I was taking. I spent 2 hours to get over the ridge and had to stop to brew a cup of tea just

### SMS CENTRAL COMMITTEE MEETS AGAIN WALL

The Central Committee of the Ski Mountaineers Section met on 8 Mar 1983, at the home of Andy Fried. Present were: Goebel, Crandall, Balsam VanDalsem, and Fried; absent: Roberts.

The Freasurer reported liquid assets at \$635.05, all in the SMS bank acc The following applicants for membership in the SMS, all properly sponsored and qualified/certified, were voted and welcomed into degular Member status; Secretary to send welcoming letters. This draft was discussed in depth by the SMSCC at this meeting, modified slightly, and approved. The resulting revised draft will be forwarded by the Secretary to the Angeles Chapter By-laws Committee. After return and any necessary "tune -up" and reapproval by the SMSCC, the final draft will be resubmitted to the Chapter and to the SMS members for formal vote in April or May. It has been the intent of the SMSCC in this revision process to minimize changes for reasons other than "Sierra Club requirement".
