

SKIING MT. RITTER , MAY 27-29,1995

Seven enthusiastic telemarkers met Sat. 7am at Mammoth Mtn. to ski Mt. Ritter on the Memorial Day weekend. These were Mark Bailey, Duncan Livingston, Peter Mason, Jim Valensi, Ray Smith and his friend Robert, and Reiner Stenzel. The road was still closed beyond the skilifts. Thus, we first skied up to Minaret Summit (9,175'), then down to Agnew Meadows (8,600'), after a minor detour we made it to the bridge crossing the San Joaquin River (8,100'), then ascended past Shadow Lke to Ediza Lke (9,250') where we made basecamp. It was an 8 hour day to cover the 10.5mi, +-1100', mostly XC route with

full packs. Sat eve the clouds drifted around the mountain and we all wished for good weather on Sun for our ski ascent.

We were lucky. On a sunny morning we ascended the broad 35deg chute above Ediza and turned right (North) to gain the glacier on the South side of Ritter. Jim decided to stay back to enjoy the first turns on growing corn snow. The rest ascended a steep gully leading to the Southwest summit slopes where a cold wind greeted us. We were already wondering about our descent on the crusty steep snowfield. But after a relaxed lunch on the summit (13,157') the snow had softened and he fun began. The upper snowfield was a like a long version of Baldy Bowl, followed by a steep chute which was marginally skiable due to various rocks in the way. Then came the main broad chute in the mid section of the mountain. It had the best corn snow the Sierra can offer. We left six sets of telemark tracks on this slope everyone was proud of. Before the steep dropoff we turned South back to the chute leading down to Lke Ediza. At 3pm on a sunny May day the snow on the lower slopes had turned into foot-deep mush. Deep kneebends were necessary for turning. On the 30-40deg slopes each turn released an oozing wet snow avalanche. Since they started slowly we first ignored them . But after a few turns the upper releases had gained speed and caught us from the rear. It is nearly impossible ski through a sliding mass of sticky snow. Separately, three of us had the first-hand experience to ride a few hundred feet down in a river of tumbling wet snow. The danger appeared minimal since there was a good runout and the avalanche depth was 1-2feet. Nevertheless, the adrenaline flows as one tries to stay balanced on a river of rolling big snowballs. Within a few seconds after coming to a halt it was a struggle to get the skis out of the heavy, setting snow. We were totally wet. This experience taught us a valuable lesson: respect the big ones.

After arriving at basecamp four of us decided to pack up and ski out to the San Joacquin river. Then, on Monday we had a shorter distance out via Agnews Mdw, Minaret Summit to the cars at Mammoth. It was my second year skiing Ritter and I again fully enjoyed it, especially in such good company.

REGLUING YOUR SKINS-A LESS STICKY SOLUTION

Before the snow flys is a good time to check out your ski gear, and make sure it is in good repair. One item that may require special time consuming attention are your climbing skins. How well were they sticking on your last tour? Were they falling off the tails of your skis, or did they dry out over the summer? They may just need some spot reqluing, but if they are not sticking then a complete regluing job is necessary.

Depending upon how clean the old glue surface is, you may be able to stretch the current glue job by adding a little new glue at the tail. However, if the glue surface is not very sticky, or it is dirty, the old glue needs to be removed, and new multiple glue layers added. Getting the old glue off is a very messy project, but trying to add new, multiple even layers is a real art. If not done carefully, and properly, you can easily end up with a less than satisfactory result. Fortunately, there is now a clean, and not very expensive solution. Ascension Enterprises, the Colorado manufacturer of excellent climbing skins, with a super sticky glue, have developed a regluing service that will clean and reglue any skins except Ramer. Last winter, Ascension directed me to mail my skins to Dana Hagenson, P.O. Box 463, Ridgeway, CO 81432, and for \$25.00 plus \$3.00 for return postage, my skins were returned within a week with a new glue surface that was just like new, and so sticky I could hardly peel them apart. SUPER LOOP BINDING FAILURES IN THE BACKCOUNTRY

If your skis are mounted with Rainey Super Loop metal cable bindings, purchased in the last 2 years, beware, the cables may break with only 10 to 30 days of use. It appears that the cable strength is not sufficient to withstand the stress caused by very stiff boots such as the plastic Scarpa Terminators. SMS members Don Pies and Mark Goebel both experienced broken cables while wearing Terminators. Don broke 2 cables just where they exit the side cable guides while skiing the Selkirks in Canada last April. Fortunately, he was carrying spare cables. My cable broke just minutes from Pear Lake in Sequoia during a rain storm. Mine broke at the toe where the cable exits the binding, the most common failure point according to Rainey. I did not have a spare cable,

but, was able to hold my boot in the binding using a pack strap through the toe of the binding and around the back of my boot. Rainey was very good about replacing the cables, and provided wire to wrap around the cable at the toe stress point. The side guides should be carefully examined for sharp edges and filed if necessary. For 1995-1996, the binding has been redesigned as a front throw binding with a stronger cable, and it is compatible with the Voile release binding. if you continue to use the older model, be sure to carry spare cables or pack straps, or you may be in for a tough walk out. Dear Ostrander Supporter:

We are pleased to announce that the Ostrander Ski Hut will be open for the 1995/96 winter season. The hut was closed last year because of National Park Service (NPS) concerns about the waste disposal system. No permanent solution to the problem has been determined, but the National Park Service has approved the opening of the hut this year on a zero waste discharge basis. This means that all human waste, both liquid and solid, will becol-lected, then packed out at the end of the season. We plan touse 10-gallon "ammo" cans, similar to those used for rafting trips, for that purpose.

In order to provide for the additional expenses of opening the hut for the coming season, the charge per person/per night will be raised to \$20. The monies collected from the fee will pay for the interim waste system and a number of other propane and water system adjus-tments that have been requested by the NPS. If thereare any surplus funds, they will be dedicated to the construction of the permanent waste system for Ostrander that is still in the design stages.

We appreciate all the interest and concern that Ostrander users have expressed in the last year. May the coming season be a snowy one.


